Status by Bente Moen, UiB

There have been some activity in the media this summer, regarding the effect of losing the quota scholarship. Newspaper contributions and a letter sent from the Forum board were attached to the agenda. Here is an email answer from SIU, received 6/8-18:

*Takk for brevet og for interessen for evalueringen av avviklingen av Kvoteordningen også fra Forum for global helseforskning. Evalueringen er nå inne i sin slutfase. Til evalueringen har analysebyrået ideas2evidence, som dere viser til i brevet, i samarbeid med oss valgt ut begrenset antall institusjoner og fagmiljøer til dybdeintervjuer. Disse intervjuene er nå gjennomført og i ferd med å bli analysert. I tillegg vil vi i evalueringsrapporten gjøre rede for hva som skjedde da Kvoteordningen ble avviklet og erstattet av nye ordninger som NORPART, UTFORSK og INTPART. Denne redegjørelsen vil også inkludere KDs og SIUs dialog med sektoren og andre interesserte parter i denne forbindelse og den politiske interessen for og debatten rundt avviklingen av Kvoteordningen. Deres brev passer godt inn i denne sammenhengen.*

*Vi tillater oss å påpeke at denne evalueringen ikke gjelder selve Kvoteordningen, men vil se på avviklingen av ordningen og hvilke konsekvenser det har fått på norske UH-institusjoner.*

- The board needs to find out the legality of the registry; how new regulations will (potentially) influence our membership registry. Bente will check these things as soon as the new regulations are in place (endringer i Personopplysningsloven kommer nå i vår).
- The form should not have a UiB-logo.

## **20/18 Summary of the conference in Oslo**

The conference was a success. Informal networking. UiO did a great job.

The location was very nice. The participants were a mix of young and old. The Forum was not promoted enough compared to Global Health Norway, with their roll ups and conference material. This was unfortunate, as this was a Forum conference, not a GHN conference. The General Assembly could have been promoted more.

The numbers: 154 persons signed up for the conference; in addition did we add volunteers, board and scientific committee to the list. At the start of the conference, there were approx. 130 people present. There is still some work left to follow up the financial side of the conference. Quite a few of the people who signed up for dinner, did not show up.

The poster sessions ended with fewer posters than we planned for. We need to look at the routines for the poster sessions and reject the ones who have not paid the registration fee. Also, there is need to communicate better with supervisors/students together.

## **21/18 The 2019 conference – switched place with agenda no 22**

Global Health Norway will be responsible for the finances, how should Forum contribute?

Inger Scheel, representing UiT, Center for arctic and global, Tromsø has signalled interest in arranging the conference. UiT will receive a letter from Global Health Norway with information about the requirements for the host. The location must be chosen before August; ideally, it should be decided before the summer holidays.

Tromsø wants to arrange the conference in June. Needs to keep in mind that there will be two days of PhD-conference right after.

## **22/18 News from Global Health Norway – switched place with agenda no 21**

News from GHN board meeting May 3 in Oslo.

Global Health Norway will prepare a document on hosting conferences. From 2019 there is no longer funding for Forum-conferences. Future annual conferences in Global Health will be initiated by Global Health Norway, who also will have a main- and financial responsibility for the conference.

Academic environments will suggest hosts with one responsible contact person. The chosen institution must provide committee and location for the conference; and make a plan and a budget for the conference. Global Health Norway recommends cooperation with Forum. Forum members are needed for scientific tasks; program, abstract evaluation.
